Terms and Conditions on the online subscription to Albaniannews.com, branch of the Albanian Daily News Newspaper, registered trademark under the company Independent Albanian Economic Tribune L.t.d (T.E.SH.P sh.p.k).

ADN (Albanian Daily News) may change, alter or withdraw any part of albaniannews.com at any time (with or without notice to you) and may also change the terms and conditions. You should regularly check Section 13 of these terms and conditions to see if any changes have been made - by using Albaniannews.com after we have posted the changes, you are agreeing to be bound by them. If you do not agree to the changes you should cease using Albaniannews.com and you may cancel your subscription to any Paid For Services in accordance with your rights set out in Section 9.

References in these terms and conditions to "ADN" (or "Albanian Daily News" or "we", "us" or "our") refer to the company operating albaniannews.com.

1. Access and Use

Albaniannews.com is accessible to paying subscribers.

ALBANIANNNEWS.COM IS NOT ACCESSABLE TO USERS RESIDING IN ALBANIA. IF ACCESSED THROUGH AN ALBANIAN IP THE WEBPAGE WILL NOT BE DISPLAYABLE.

Permitted Use: All ADN Content belongs to ADN or its licensors. ADN or its licensors own all intellectual property rights (including copyright and database rights) in the ADN Content and any selection or arrangement of the ADN Content. You may for your personal, non-commercial use:

- retrieve and display ADN Content on any compatible device;
- print a single copy of individual articles on paper (but not photocopy them);
- store such articles in electronic form on disk or on a mobile device (but not on any server or other storage device connected to a network); and
- Use spidering technology to search and link to Albaniannews.com, provided that you do not infringe the Restrictions on Use below.

Restrictions on Use: You may not use Albaniannews.com for any unlawful purpose. 2. Privacy Policy and Registration

All information received by you from your use of Albaniannews.com will be used by ADN in accordance with our [Privacy Policy](#).

This is particularly important if you subscribe to receive any Paid For Services. ADN is entitled to rely on any information you provide to us.

Each registration is for a single user only. On registration, you will choose a user name and password ("ID"). ADN does not permit any other person sharing your ID or access through a single ID being made available to multiple users on a network. ADN may cancel or suspend your access to Albaniannews.com if you do this without further obligation to you.

You are responsible for all use of Albaniannews.com made by you or anyone else using your ID and for preventing unauthorised use of your ID. If you believe there has been any breach of security such as the disclosure, theADN or unauthorised use of your ID or any payment information, you must notify ADN immediately by e-mailing us at help@albaniannews.com. We recommend that you do not select an obvious user password (such as your name) and that you change it regularly.

9. Paid For Services

(a) General

ADN operates the following "PAID FOR" services: Albaniannews.com Subscription Services, ADN newspaper Subscriptions. By subscribing to receive Paid For Service, as well as the above terms and conditions, you are also agreeing to the terms in this Section 9. ADN reserves the right to vary the Paid For Services and does not guarantee that a Paid For Service will remain paid for or that a free-of-charge service will remain free-of-charge.

You agree to pay any subscription fees at the rates in effect when the charges are incurred. If you already receive any Paid For Services through any corporate or business arrangement made with us, any payment terms below will not apply to you.

You must provide us with complete and accurate payment information. You will be receiving a Pro-Forma Invoice by our Financial Department which will be executed through a wire transfer to our Bank Account. Account details will be submitted to you included in the Pro-Forma Invoice. In the case of unauthorised payments ADN reserves the right to suspend or terminate your access to the Paid For Services. If we do not receive payment authorisation or any authorisation is subsequently cancelled, we may immediately terminate or suspend your access to any Paid For Services.

ADN will try to process your subscription promptly but does not guarantee that the Paid For Services will be available to you by any specified time. A contract with you for receipt of the Paid For Services will come into effect when ADN confirms this to you.

There is no specific time limit applying to your use of the Paid For Services on these terms and conditions. However, ADN reserves the right to suspend or terminate your subscription to the Paid For Services if you breach these terms and conditions, with or without notice and without further obligation to you.
